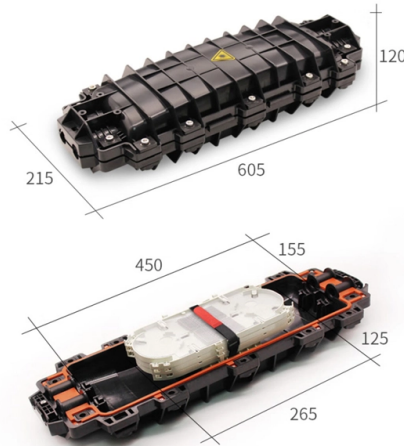


Safety Regulations for Operating Distribution Boxes



Overview

Distribution boxes should be installed in dry, well-ventilated areas close to the power supply to reduce power loss and ensure safety, avoiding humid or corrosive environments. The bottom edge of the box is typically positioned 1.5–1.8 meters above the ground for convenient operation and inspection. Boxes should be firmly fixed using appropriate brackets or screws to prevent movement or tilting due to vibration or collision. Outdoor boxes should avoid direct sunlight and reflective surfaces to minimize heat accumulation.

Wiring and Electrical Safety

- Power must be turned off during wiring to prevent electric shock.
- Use high-temperature resistant copper wires with cross-sectional areas suitable for the load current.
- Ensure clear labeling of wires and avoid exposed copper to prevent short circuits.

- All cable inlets and cover joints should be properly sealed to maintain safety .
- Overcurrent and short-circuit protection must be provided using circuit breakers or fuses, with ratings matched to the load .

Grounding and Protective Measures

- The metal enclosure, electrical installation board, and appliance casings must be reliably grounded .

- Protective neutral wires should be connected through terminal boards to ensure safety .

- Arc flash hazard analysis should guide the use of personal protective equipment (PPE) during maintenance .

Operational Precautions

- Avoid overloading the distribution box, especially during high-temperature conditions, as excessive heat can cause insulation aging, contact burning, and equipment failure .
- Use high-quality, low-resistance components to reduce heat accumulation and extend service life .
- Ensure proper installation techniques, such as using crimped lugs instead of twisted wires, to prevent overheating and connection failures .
- Maintain separate circuits for power and lighting distribution when required, and implement three-level power distribution for construction sites or complex systems .

Maintenance and Inspection

- Regularly inspect the box for temperature, corrosion, and loose connections .
- Check voltage and current ratings to ensure the box can safely handle the expected load .
- Clean ventilation openings and ensure proper airflow to prevent overheating .
- Replace worn or damaged protective devices promptly to maintain operational safety .

Compliance with Standards

- Follow NEC, IEC, and local electrical codes to ensure minimum safety standards .
- Proper labeling, safe working clearances, and adherence to grounding practices reduce the risk of electrical accidents .
